SUBJECT: COMMITTEE VACANCIES

INFORMATION ONLY: There are currently four (4) vacancies on the Solid Waste Management Planning Committee and one (1) vacancy on the Brownfield Redevelopment Authority Board.

SOLID WASTE COMMITTEE: The County is currently considering some operational changes at Smiths Creek Landfill that may require an amendment of the Solid Waste Management Plan. In order to amend the Plan, the Solid Waste Management Planning Committee would need to meet a couple of times in order to be brought “up-to-speed” and consider any proposal. Currently we have 4 vacancies on the 14-member committee:

- 1 General Public
- 1 Township Government
- 1 Environmental Interest
- 1 Solid Waste Management Industry¹

As always, it is important for the Committee to operate with a full complement of members. Please consider your constituency and any potential candidates who may have interest in serving on the Committee. For your information I have attached excerpts from the solid waste statute and rules pertaining to the makeup of County Solid Waste Management Planning Committees.

BROWNFIELD REDEVELOPMENT AUTHORITY:

The Authority Board is made up of representatives from each Board of Commissioner District and the directors/designee of the Metropolitan Planning Commission and the Economic Development Alliance. The Board currently has a vacancy in District Three (3).

¹ According to Michigan Statute, “Solid waste management industry” means any of the following:

- (i) An individual or organization that derives a substantial portion of its income from the collection, transportation, or disposal of solid waste.
- (ii) A manufacturing industry that collects, transports, and disposes of solid waste that is generated incidental to its operation.
- (iii) A unit of government or subdivision thereof that collects, transports, or disposes of solid waste within its political boundary when 4 members, as defined in paragraphs (i) and (ii) of this subdivision, cannot be found.
