Resolution 22-11

Placing Proposed St. Clair County Ambulance Services Millage on Ballot

Whereas, the Board of Commissioners of the County of St. Clair recognizes the need and value of ambulance services provided to the citizens of the County of St. Clair; and

Whereas, the need and cost for services is increasing at a rate greater than the resources available to adequately provide for those needs; and

Whereas, Article IX, Section 6 of the Michigan Constitution of 1963 provides that the fifteen (15) mill limitation on property taxes therein imposed may be altered by a vote of the majority of the qualified electors of the County;

Whereas, Ambulance Providers in St. Clair County have recommended that a request to levy a tax of .5 mills to provide funding to be used exclusively for ambulance services in St. Clair County be placed on the August Primary Ballot; and

Whereas, each municipality has the ability to provide or contract for ambulance services with the provider of their choice: and

Whereas, it is the desire of the Board of Commissioners to permit the electorate of the County to express its view on the question of the aforementioned Ambulance Services Millage.

Now, Therefore, Be it resolved that:

The Clerk of the County of St. Clair is hereby directed to place on the ballot for the primary election of August 2, 2022, a proposition for the imposition of an addition not to exceed .5mills to be used for the sole purpose of providing ambulance services in the County of St. Clair, and that the proposition shall be placed on the ballot in the following form:

Proposition_____

ST. CLAIR COUNTY AMBULANCE SERVICES MILLAGE

1. Shall St. Clair County levy a new millage of .5 mills per year, for a period of four (4) years, beginning 2022 through 2025, generating estimated revenues for the first year the millage is authorized and levied of approximately \$3,362,408 to be used and disbursed to local municipalities for the sole purpose of providing operating and capital funds for ambulance service in St. Clair County?
2. Said election shall be held and conducted and the results of the said election shall be canvassed in accordance with the provisions of the State law pertaining to the submission of such questions to the electors entitled to vote thereon and that the County Clerk of St. Clair County and the Treasurer of St. Clair County shall do and perform all acts required by law

for the calling and effecting of such election, and that the said Clerk shall within five (5) days of said election file with the County Treasurer for St. Clair County a certified copy of the official declaration of the results of said election.
